Database Summary: Why Use COBRA?

COBRA (Complete Business Resource Advisor) is a key source of information and advice for anyone who wants to start a business in the UK.

Details

- COBRA is a continually expanding business encyclopaedia with information about starting and running a business.
- COBRA's directory includes around 4,000 factsheets, market reports, contacts, funding resources and support.

Strengths

- COBRA is a unique source of information for people starting small-scale businesses.
- Its search and browse options are easy and simple to use.
- The industry factsheets are short and simple and have a clear structure.
- COBRA has a generous download allowance.

Weakness

- COBRA reports are limited to UK industries.
- COBRA reports do not contain many market research statistics.

Alternatives

- For market research try Avention, Mintel, or IbisWorld

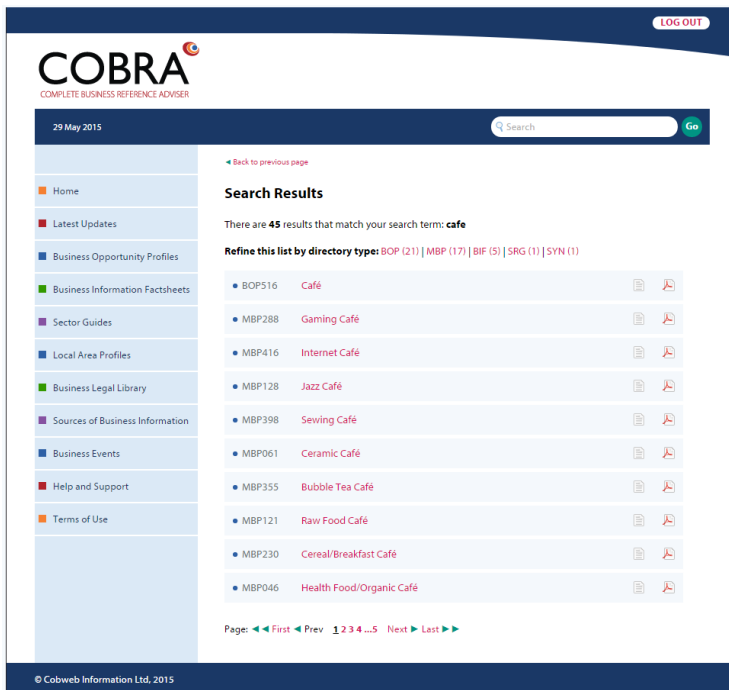

How to Use Quick Search

Enter a word or phrase into the *Search* bar at the top right of the COBRA homepage and click *Go*:



Relevant documents like Business Opportunity Profiles and Business Information Factsheets will be shown in a list of search results:



Click either a document name or an icon to the right of a document to look at the corresponding factsheet or profile

How to Download a Document

Click the following icon to open the document as a PDF:



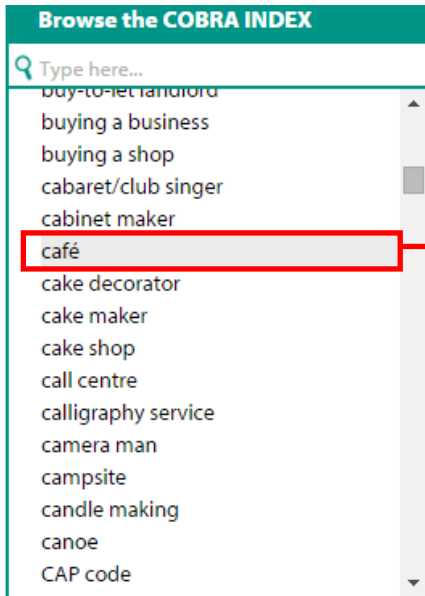
When the document is open, click the *Save* icon to download and save a copy:



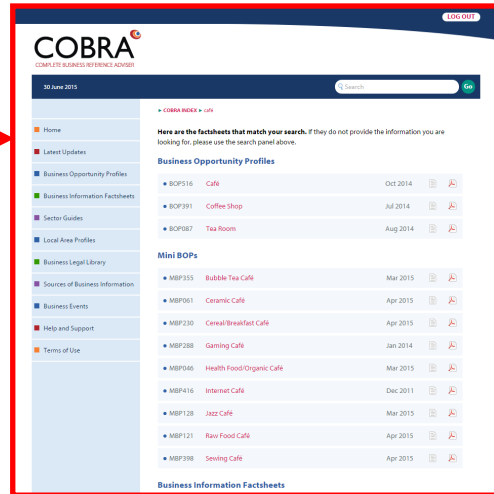
Please note that, depending on your browser, the above icon might look different .

The COBRA Index is available from the COBRA homepage. To use the index either scroll through the alphabetical list or type a word or phrase into the *search* bar.



For example, click *Café* to open a list of resources related to opening a café

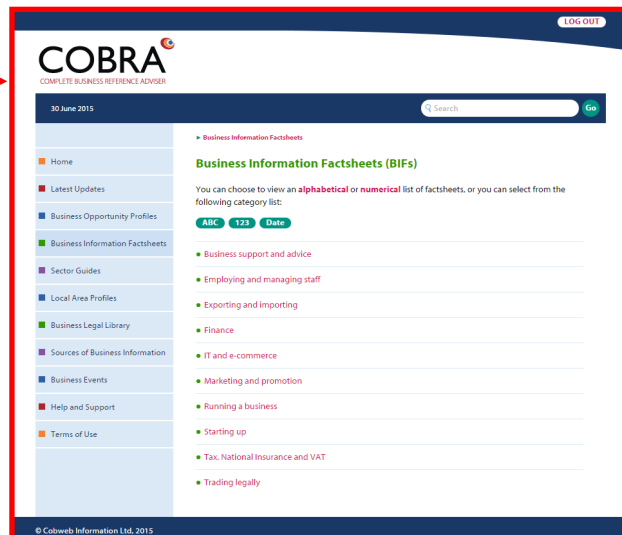


COBRA Directory Search
